Dear VCS Friends.

During the 2022 holiday season we met "Jean", a young man experiencing a mental health crisis. He saw our sign and knew enough English to know we were a safe haven, and he walked in. Jean was not our client and only spoke Creole. When he arrived, it was dark outside, and our Clinic was at its busiest. He communicated enough for us to know he needed to be seen. Within 10 minutes of seeing our sign on Main Street and entering the building, Jean was sitting with a Creole-speaking Clinician and together they were able to help Jean through his crisis. Jean remains with VCS and continues to work with the clinician that saw him that night. It's wonderful when things work out! However, this isn't just happenstance. As an anti-racist and social justice organization, we are ever vigilant to provide accessible equitable care to everyone, in their language, to the very best of our abilities.

Of our many stories, this young man's experience is seared into my heart because it shows our staff's teamwork, their compassion and ability to work quickly to give people what they need in the here and now. That night, Jean was not "our" client, but we turn no one away. That is what we have done since 1970. In 52 years, times have changed and decreased funding has significantly impacted on our ability to provide services at no cost. It's a business model catastrophe in the making. If we don't charge, then we don't have any services to offer anyone. If we do, we may negatively impact those who most need our services. How do you provide excellent care at no cost and with dwindling funding? Any person who balances their household budget knows the answer. The truth is you can't.

Let me be clear, the VCS heart and soul is the same as it was in our inception. We are here to meet the needs of our community regardless of their ability to pay. To that end, we turn our attention

FAMILIES IN NEED OF SUPPORT

Amelia is 11 years old and had difficulty asking for what she needed in school. **VCS FINS** helped Amelia to find her voice! Amelia now has self-confidence and the ability to negotiate relationships with her peers. Through her work with VCS, she will grow into a confident person ... changing the course of her life!

STUDENT ADVOCACY

During COVID, 15-year-old Ana, not only lost several family members to the illness, but she had also been hospitalized. This frightened her and she developed severe anxiety with panic attacks which threatened her ability to pass her grade. Through **Student Advocacy**, we accelerated her admission into our **VCS Clinic**, and she was soon receiving care. Not only did we provide her with the needed documentation for school, but our Dr. Price also recommended home instruction! In her safe space, Ana was able to catch up on all of her assignments! Ana soon returned to school and is doing very well.

MENTAL HEALTH CLINIC SERVICES

For 2 decades, Tom has experienced anxiety and depression as a result of leaving his home country and coming to America. With an unfamiliar language and culture, Tom began to feel inadequate and uncomfortable, and he soon could no longer leave his home. Our **VCS Clinic** helped Tom to belong. He is resilient and is regaining his confidence! It shows that we are never too old to find out we belong.

VCS COUNSELING - GRUPO DE MADRES

"Through **El Grupo de Madres** I found the support I needed. VCS and the other parents helped me feel that I could carry on. Thank you for your donations of food and clothing, but also for being that bridge of information to all the aid that exists in our county. Today I am strong! Thank you for helping me to see my value."

VCS COUNSELING - PUENTES

After experiencing horrific violence and rape at the hands of her husband, Teresa came to the United States for a new life. In her own words: "I found my safe space with **PUENTES**. Thanks to **PUENTES**, I have learned to conquer my fears, insecurities, and walk with my head held high. I've been able to let go of my inner guilt, thinking that somehow, I was at fault for what he did to me. I am now a person of value, courage, and strength!"

SERVICES FOR OLDER ADULTS & THEIR FAMILIES

Mary is no longer lonely. As a homebound 95-year-old widow, she has had more than her share of social isolation. Now, she receives weekly visits with her **VCS Volunteer Counselor** where she shares her fears of dying, past regrets and hopes for the future. Mary no longer feels alone. In VCS she has found a friend and her life's meaning.

RELATIVES AS PARENTS

Sonia thought she was done raising children. Now, she finds herself raising 2 grandchildren. Her daughter is mired in substance use the way so many Rocklanders are. She loves her grandchildren, but it can be a difficult and lonely experience. Through her weekly **RAPP Support Groups**, Sonia finds camaraderie among her new friends; she shares issues and is listened to with compassion and understanding. Sonia no longer feels alone.

DOMESTIC VIOLENCE PROGRAM FOR MEN

Intimate partner violence is devastating to families. It's behind closed doors violence, making it difficult to know which of our friends, family, or neighbors experience this. Whatever brings the men to our **VCS DVPM** class, we turn it into an opportunity for him, his partner, and the entire family. Jim shared, "I learned a lot from the class. I learned that I can act differently toward my partner in stressful situations. Also, I learned that it's up to me to change. Thank you for taking the time and effort to teach this class."

PARENTING APART

For Jade, separated from her husband, she felt stressed, isolated, embarrassed, and even angry. She didn't know how to co-parent while there were so many damaging and derogatory statements from both sides. Through the **VCS Parenting Apart** classes, Jade was awakened to another's point of view. That of her child, who was experiencing her own pain and suffering because of the separation. Jade hadn't realized she placed her child in the middle of the conflict. Through this revelation, Jade was able to pivot, take control of what she could and let go of the rest. Jade now places her child first!



DIVERSITY, EQUITY, INCLUSION & BELONGING

These are strong VCS values. Since our inception, we have practiced through an anti-racist and social justice lens. We believe that DEI & B work must offer education and provide an atmosphere of respect and inquisitiveness. We will move beyond "tolerance" to "acceptance"; from a "sanitized" environment to an environment that "honors" everyone. We will continue to expand our staff and volunteer trainings through a collaboration with NYAPRS that will focus on all areas of DEI work. We will also continue our focus on recruiting and retaining our dynamic and exceptional staff so as to represent the diverse community in which we service.

UR SPACE CLINIC AT KAKIAT ACADEMY

Our School-based Mental Health Clinic expansion continues in the East Ramapo Central School District with the Kakiat STEAM Academy. Applications have been completed and we are awaiting OMH final approval. VCS has been sought after to provide Clinic-level services in our local schools to support the children who experience mental health challenges. We anticipate our continued expansion to other schools in the district in 2023 and beyond.

FINKELSTEIN MEMORIAL LIBRARY

VCS has partnered with the Finkelstein Memorial Library in expanding their community services. VCS will open up a Mental Health Clinic as part of this collaboration and they will provide VCS with a suite of rooms for this purpose.

OFF-SITE PSYCHOTHERAPY

The NYS Office of Mental Health's revised regulations now allow for off-site services. The Clinic now has the flexibility to provide treatment outside the office setting and in the community.

INTEGRATING SPECIALISTS Integrating Peer Specialists into the Clinic as part of our multi-disciplinary team. Peers are people who have been successful in their mental health recovery process who help others experiencing

VOLUNTEER COUNSELING

PIONEERING WORK

Since 1970, VCS Inc. of Rockland County, New York, has pioneered the innovative use of community lay people to do high-level counseling for clients with a wide range of social problems. In 1970, a group of family court judges in New York State expressed concern that many families seeking aid through their courts appeared to be in need more of counseling assistance than of judicial remedies. Child abuse, domestic violence, parent-adolescent conflict, and post-divorce problems were only some of the difficulties for which the judges were asked to provide solutions. A Ford Foundation grant was secured to test this hypothesis. Nearly fifty years later, VCS Inc. is an established part of the service delivery system in Rockland County. The agency works closely with the family court, schools, the Center for Safety & Change and other community agencies. VCS counsels residents of Rockland County and beyond and works with court-mandated referrals and voluntary self-referrals. The community often turns to VCS to fill a service gap when a local problem is not being well addressed.

VCS CLIENTS

VCS serves battered women, teenagers, parents of teens, men who batter, people with marital problems, people with reactive depression, and families experiencing divorce or illness. VCS also works with people who are struggling with issues of aging, caregivers of the elderly, parents who are abusive or neglectful of their children, and people with reactive anxiety. VCS provides individual, couples and family counseling to adolescents and adults. You do not need to have health insurance and do not need to be a US citizen or documented to receive services. A client who is motivated to continue counseling may attempt real changes in his or her life - leaving a marriage, changing jobs, going back to school, developing a talent or interest, or risking new relationships.



VCS VOLUNTEERS

We find that almost all people have the ability to work through their concerns if they have a safe place to talk with a good listener. Counselors at VCS are therefore trained to create a safe, non-judgmental and supportive space for you to share and work through your concerns. The profile of a typical volunteer has changed over the years. In 1970, many volunteers were women at home raising school-age children. A recent training group included two psychiatric nurses, a child care worker, the assistant to a college dean, a real estate broker, a lighting technician, a vocational rehabilitation counselor, a veterinarian's assistant, two homemakers, and a teacher. Recent groups also have included an increasing number of men.
